

## **CAS in Responsible Business Conduct**

### Topic

Recent regulatory changes and the growing public awareness of the issues related to Responsible Business Conduct (RBC) further increase the pressure on states and companies to conduct business activities responsibly and sustainably, taking into account related risks for people and the planet.

This CAS is aimed at supporting businesses as well as public institutions and agencies with precise and specialized knowledge that allows them to adequately navigate the intricate web of emerging regulatory requirements at the national, regional, and international level. Raising societal expectations and the dynamic regulatory environment call for a new generation of business professionals with expertise on RBC who can anticipate and assess the impacts of business activities on people and the planet and prioritize measures to prevent, mitigate, and remedy such impacts. These professionals need sound and comprehensive knowledge in the interdisciplinary area of Responsible Business Conduct as well as the skills to apply this knowledge in their respective fields of work.

To this end the UZH provides a Certificate of Advanced Studies in Responsible Business Conduct (CAS in RBC) which is specifically tailored to professionals and practitioners. The key international concept of Responsible Business Conduct which is embedded in the recently updated OECD Guidelines for Multinational Enterprises on Responsible Business Conduct and in the UN Guiding Principles on Business and Human Rights (UNGP) will constitute the basis of this course. The concept of risk-based due diligence is at the heart of the CAS, providing participants with tools to analyse current challenges and develop implementation strategies in their specific field of work.

## **Program Overview**

Admission Criteria	The CAS is open to university graduates with a minimum of two-year professional experience or in exceptional cases comparable qualification.
Target Audience	Professionals from business, government, civil society, and academia, such as lawyers, compliance officers and risks managers, members of management boards or boards of directors in charge of responsible business conduct/corporate governance, due diligence policies and implementation.
Modules and Assessments	The CAS in RBC offers a comprehensive virtual program with real-time sessions and self-study components of offline activities throughout the semester. Real-time sessions take place on 21 days over a one semester period. Online attendance and active participation are mandatory, with each session lasting three hours. At the end of the semester participants submit an original case study about a topic of their choice related to Responsible Business Conduct.
Number of Participants	Minimum of 10, maximum of 30 participants.
Degree	Upon completion participants receive a Certificate of Advanced Studies UZH in Responsible Business Conduct and are awarded 10 ECTS Credits.
Costs	CHF 7000.– (covers all fees and materials)

Format, Time, Application The CAS runs for one whole semester and is conducted entirely online to reach participants internationally.

To accommodate most time zones online, lessons will be conducted between 12 am and 3 pm Central European Time on Friday and Saturday, generally following a two-week rhythm.
